Processes and operational matters

Development processes within CEN-CENELEC Joint Technical Committees

A Task Group 'JTCs simplification', under the umbrella of CEN-CLC/BTWG 14 'Rules and Processes', has been assigned to develop a proposal to BTs towards a clarification of all aspects relating to deliverables development within JTCs (delegation of NWIs approval, work under the Vienna and Frankfurt Agreements), addressing as well aspects related to experts' appointment, registration, participation and visibility in JTCs. The proposal, expected for October at the latest, should strive for alignment with ISO-IEC JTCs' way of working.

Liaisons requests from companies based outside Europe

Over the recent years we have noticed increasing requests for liaisons with CEN and/or CENELEC Technical Bodies from consortia/fora of international undertakings, which are based out of Europe. Considering that the criteria in <u>CEN-CENELEC Guide 25</u> 'The concept of Cooperation with European Organizations and other stakeholders' need to be re-assessed to take into account the European political and business landscape and the new fast-growing technological domains, and underlining that NSBs/NCs are the natural entry points to standardization work for national stakeholders, the BTs recommended CCMC (for the preliminary assessment) and Technical bodies (for approval) to pay careful attention to the nature, location and membership of the organizations requesting liaisons, and consult BTs for guidance when need be.

The BTs also invited the Task Force supporting CCMC in the evaluation of current ongoing Memorandums of Understanding to review CEN-CENELEC Guide 25 accordingly.

New Bodies set up by BTs

CEN-CENELEC Coordination Group on 'Hydrogen'

In the frame of the EU Strategy on Hydrogen, the CEN-CENELEC Coordination Group on Hydrogen (CEN-CLC/COG H2) (secretariat: DIN) has been set up to keep an overview of the complete hydrogen value chain, putting in place coordination mechanisms among relevant technical bodies in order to develop a coherent set of standards relating hydrogen production, transmission, storage and distribution infrastructures as well as industry use and end-use. The COG will also monitor the progress of work at ISO & IEC level, and ensure liaison with the European activities when relevant.

CEN/TC 477 'Sustainable production of raw materials from mining related activities'

CEN/TC 477 (secretariat: SIS) has been tasked to develop standards on the sustainability of production of raw materials from mining related activities covering the whole value chain, from exploration, extraction, treatment, smelting, refining, other processing, as well as recycling and mine closure and reclamation, to minimize the negative impacts from mining through its life cycle. Energy raw materials are excluded from its scope, as well as those aspects already covered by CEN/TC 472 'Rare earth elements'.

CLC/BTTF 177-1 'Managing issues related to harmonization of European standards within the CLC/SR 96 portfolio'

CLC/BTTF 177-1 (convenorship: DKE) will help CLC/SR 96 'Transformers, reactors, power supply units, and combinations thereof' (secretariat: AFNOR-CEF) develop European elements to harmonized Standards within their portfolio. Once the European elements have been published, the corresponding deliverables will be transferred back to CLC/ SR96 for maintenance

CLC/BTTF 177-2 'Revision of EN 50075:1990'

CLC/BTTF 177-2 (convenorship: BEC-CEB) will revise EN 50075:1990 'Flat non-rewirable two-pole plugs, 2,5 A 250 V, with cord, for the connection of class II-equipment for household and similar purposes' (PR=355). After its publication the new deliverable will be transferred for maintenance to CLC/SR 23 'Electrical accessories' (secretariat: BEC-CEB) and the BTTF disbanded.
