Webinar for CEN TBOs - New process for TS & TR Questions & Answers

1	For monitoring: will the system also trigger alert reports via email (e.g. at monthly intervals)	Alerts for overdue work items including TSs & TRs (stage 30.99) are sent to TB secretaries 3 months before the due date. This gives time for TCs to take relevant actions.
2	Can the tolerance requested be for any period of time, or is it a 9-month period?	Tolerances can be requested once for a 9-month (39 weeks) period only.
3	I registered yesterday a TR on Projex area, if I well understand it is not concerned by this enlarge period of drafting. But could I change the planning later?	Indeed. You cannot plan stage 30.99 anymore since this stage has already been registered in the database (i.e., before 2024-03-01). However, you can use the one change option once to modify the target date for stage 30.99. And in addition, you can also request a 9-month tolerance.
4	Is it possible to have a normative national annex to a TS (same as for an EN)?	No. There is no implementation obligation for TSs.
5	Will there be another alert between the "12- week-to-30.99" alert and the target date?	Yes, alerts are sent monthly until the due date (or where relevant exceeded the applicable tolerance) for stage 30.99.
6	Can prEN's be used as reference in EC regulations?	Normally, the EC would not make reference to unpublished docs in legal documents. In case of reference in a standard supporting a regulation, it is possible but only under certain conditions (to be checked case-by-case).
7	How can a TR respond to a standardization request if no requirements are allowed in a TR?	TRs could be requested via SReq even though they provide only information and no requirements. For example, in some cases the development of a TR could give useful complementary information to requirements.
8	Ts can be in Sreq, but TR could?	It is rare but some SReqs do request the development of TRs.
9	Bullets 3 and 5 could be combined to read "TSs & TRs can be revised but not amended'?	The modalities for revision of TSs & TRs differ according to IR2. A TS can be replaced by a new edition (new date) of a TS. A TR can be replaced by a new edition (new date) of the TR with the same number. This is currently being discussed by BTWG14 'Rules & Processes' for an improved wording to be reflected in a new version IR2.
10	Is it possible to conduct a 2nd TCA for a TR or TS in case technical comments received	Yes, it is possible. In such case, the TB needs to take a decision and then contact his/her CCMC



	require further redrafting work prior to proceeding to publication?	Sectorial PM requesting a BT decision to launch a 2^{nd} vote on the TS or TR.
11	Who has to decide on the second vote? TC or BT?	TC via TC decision then BT via BT vote.
12	E-mail request to data for "one-change option" & tolerance ONLY if target date for 30.99 is over?	One change option should be done by the TB secretary via Projex Working Area under 'Actions requiring no TB decision.
		Tolerance requests can be by sending an email to dataservice@cencenelec.eu. Both should be requested before the Target Date (TD) for 30.99 has been reached (ideally when receiving the alerts or before). Once the TD is reached it is too late.
