





Essential Requirements



What are Essential Requirements?

- Definition: Essential requirements are the fundamental criteria specified by EU legislation that products, services, or processes
 must meet to ensure safety, health, environmental protection, and other important public interests.
- Legal Framework: Essential requirements are outlined in various EU directives and regulations, and they form the basis for the
 development of harmonised standards.
- Key feature: Compliance with these essential requirements is mandatory for products to be legally placed on the EU market.
- Examples: safety requirements for electrical equipment, environmental standards for emissions, health standards for consumer products.

Presumption of Conformity



What is the Presumption of Conformity?

- Definition: Presumption of Conformity is a legal concept within the EU legal framework, whereby products, services, or processes that comply with harmonised standards are automatically presumed to meet the essential requirements (i.e. conform to) the relevant EU legislation.
- Purpose: Simplifies market access by reducing the need for further conformity assessments.
- Key feature: manufacturers may voluntarily comply with harmonised standards to demonstrate conformity of products with essential requirements.
- Legal Framework:
 - Regulation (EU) No 1025/2012: on European standardization
 - New Legislative Framework (NLF): includes Decision No 768/2008/EC and Regulation (EC) No 765/2008
 - Harmonised Standards: Developed by European Standardization Organizations (ESOs)

Link with EU legislation



Standardization Request is a precondition for citation of harmonized standards in Official Journal of the European Union (OJEU)


Harmonized Standards must be assessed and have the following 'European elements'

- ► Annex ZZ (i.e table establishing the relationship between the clauses of the standard and the regulatory requirements)
- ► Other European elements (e.g table establishing the relationship between the international and the European normative references)
- → To be prepared by the European Technical Committee

Innovative Process – homegrown hEN




Workflow



'New' Process for Parallel Projects (hENs)





Key points for // development



▶ Start the process as early as possible

► European TC invited to closely follow work at international level and to develop Annex Z in parallel with CD draft

- ► 'New' Process will only apply if:
 - ► CD available
 - ► European Elements available
- **▶**Communication is key
 - ► Ensure communication flows between CEN-CLC/TC (interaction with the HAS consultants) and ISO-IEC/TC (writing the standard)
- ► <u>Common checklist</u> not mandatory, but highly recommended when drafting European Annexes

What is an Annex Z



- ► Annex ZA (CEN) and Annex ZZ (CENELEC)
 - ▶ Informative
 - ▶ Indicates relationship between requirements of a Regulation aimed to be covered and the applicable clauses
 - ► As many Annexes ZA/ZZ as Regulations aimed to support
- CEN: Annex ZA with table ZA.1
- ► CENELEC: Annex ZZ with a table ZZ.1
- ► Templates available on CEN and CENELEC websites:
 - CEN BOSS
 - CENELEC BOSS

How to draft Annex ZA/ZZ



- ► <u>Table ZA.1/Table ZZ.1</u> shall indicate the relationship between the Essential Requirements and the specific clause(s) in the standard
- Harmonized standards does not have to cover all relevant requirements, but <u>Annex ZA/ZZ</u> must always be consistent with the real coverage of the requirements
- Provide reference(s) to specific clauses/subclauses that provide coverage of requirements, rather than whole sections of standard

Key drafting reminders




- Perform self assessment using <u>Common checklist</u>
- Draft clear and verifiable provisions



- Normative References :
 - should be dated, active, published when hEN is made available
 - ▶ Recommended to refer to a specific clause within the NR (to avoid issues with chains of NRs)
- ► Use <u>CCMC guidance</u> documents: do your homework ©

Role and tasks of HAS Consultants

- The activity of HAS Consultants is described in the Call for Tenders, and it is limited to the "territory" defined in Art. 10(5) and 10(6) of the Standardisation Regulation
- Their main task is to assess (draft) harmonised standards developed on the basis of a Commission standardisation request
- The time allocation of their work is mostly for assessment, with a maximum of 25% for "communication" tasks
- HAS Consultants cannot, under any circumstances, participate to the drafting of standards and to the consensus-building process within ESOs
- Their role is not to compensate possible gaps in the technical, scientific or legal expertise of a technical body

Meeting requests following HAS assessment



- Meetings adhering the below criteria are encouraged
- Meeting requests should be submitted minimum 4 weeks prior to the meeting date
- A <u>full agenda of the meeting</u> should be provided to allow the HAS consultants to prepare
- Only meetings linked to a <u>previous assessment</u> are allowed under the HAS project
- Physical meetings are possible but subject to approval by HAS Consultants

Reminder on the role of HAS consultants during meetings with TCs

What a HAS Consultant can do

- Convey the Commission's positions to the ESOs or their technical bodies
- Participate in meetings to offer clarifications on their previously completed assessments* (but max. 25% of time is spent on meetings)

What a HAS Consultant cannot do

- Contribute to standard development process
- Offer guidance to the TCs on how their standards can become compliant
- Perform Assessments on documents received from the TCs/ESOs <u>directly</u>
- Modify completed Assessment Reports
- Participate in meetings without EY approval

^{*}Consultants should check if the harmonised standards are compliant with the legislation. Technical comments on elements not linked through Annex Z are considered as recommendations.
