

New delegated decisions to TCs



Background



Increase the responsibilities delegated from Technical Boards to the Technical Bodies



Reduce administrative burden and optimise standard development timeframe



A number of decisions is **already delegated** to CEN/TCs

BT decision 008/2024

- ▶ BT agreed to delegate selected decisions to CEN and CENELEC (J)TCs
- ▶ CCMC was mandated to prepare an implementation plan

BT decision C024/2025



- ▶ BT decided to delegate three types of decisions to CEN and CENELEC (J)TCs:
 - ▶ withdrawal of deliverables
 - ▶ removal of links to legislation
 - ▶ 2nd FV requests on hENs
- ▶ Delegation will be implemented stepwise: first without automation (via CIB/CIV), followed by full IT automation after re-assessment of the decision
- ▶ Application from 1 October 2025, subject to IT readiness

New delegated decisions to TCs



Applicability

This decisions applies to WIs that are launched for approval **as of 4 February 2026**




Impacts on TC secretaries

Very little: you will keep using the same tools

- ▶ **CIB** → Three new templates
- ▶ **Formatted decisions** → New templates on CEN BOSS
- ▶ **Email to Data service** → Share the decisions after closure of CIB

Formatted decisions

- ▶ Available on [CEN BOSS](#) → Formatted decisions → 2.Decisions delegated to a Technical Committee → 2.2.Related to the Technical work
- ▶ Use these templates to circulate the TC decision once the CIB has closed

decision-making across CEN and CENELEC

Change of approval criteria



BT decision C023/2025

- ▶ BT decided to align the approval criteria across CEN/TCs, CLC/TCs and CEN-CLC/JTCs for:
 - ▶ withdrawal of deliverables
 - ▶ removal of link to legislation
 - ▶ amendments/revisions not modifying the scope

! Voting criteria are **embedded in CIB** and to related voting results


